A RESOLUTION

Amending the 1989, 1990, 1991, and 1992  
Community Development Block Grant Programs  
and Authorizing the Reallocation of Unexpended  
Funds from those Program Years

WHEREAS, the Evanston City Council with passage of City Resolution 2-R-89, 4-R-90 6-R-91, and 2-R-92 did approve applications for Community Development Block Grant Entitlement funds and did direct the City Manager to file said applications with the United States Department of Housing and Urban Development; and

WHEREAS, the City of Evanston's applications were approved by said United States Department; and

WHEREAS, unexpended funds are available after implementation of certain Community Development Block Grant program activities; and

WHEREAS, reallocation of said funds would require that the City of Evanston's previous applications be revised; and

WHEREAS, the Housing and Community Development Act Committee did hold two public meetings on October 20 and November 17, 1992 to hear public opinion on said reallocations according to the Community Development Citizen Participation Plan;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Evanston, Cook County, Illinois, hereby amends its 1989, 1990, 1991, and 1992 applications and authorizes the following reallocations to the 1993-94 Program Year:
