A RESOLUTION

Amending the 90/91 and 92/93  
Community Development Block Grant Programs  
and Authorizing the Reallocation of Unexpended  
Funds for the Management of the  
1817 Church Street Building

WHEREAS, the Evanston City Council with passage of City Resolutions 4-R-90 and 5-R-92 did approve applications for 1990-91 and 1992-93 Community Development Block Grant Entitlement funds and did direct the City Manager to file said applications with the United States Department of Housing and Urban Development; and

WHEREAS, said United States Department approved the applications; and

WHEREAS, the Evanston City Council did appropriate \$10,000 in 1990-91 Community Development Block Grant funds for undertaking safety and leasehold improvements at the 1817 Church Street building; and

WHEREAS, all safety and code improvements have been completed; and

WHEREAS, there remains approximately \$7,315 unexpended from said appropriation; and

WHEREAS, the City of Evanston is soliciting proposals for the total redevelopment of 1817 Church Street building; and

WHEREAS, the City funds appropriated for the management and disposition of said property will be depleted this spring; and

WHEREAS, the City's Housing & Community Development Act Committee did direct City staff to request authorization from the Evanston City Council to utilize a portion of the unspent appropriation from the 1990-91 1817 Church Street safety/leasehold improvement project for the continued temporary management of the 1817 Church Street property until final disposition of the building is determined; and

WHEREAS, reallocation of said funds would require that the City's 1990-91 and 1992-93 applications for Community Development Block Grant funds be amended; and

WHEREAS, the City's Housing and Community Development Act Committee did hold a public meeting on February 9, 1993 to hear public opinion on said reallocation of funds as required by the Community Development Citizen Participation Plan; and

WHEREAS, said City Committee did vote to approve said reallocation and to recommend to the City Council passage of this Resolution;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Evanston, Cook County, Illinois hereby amends its 1990-91 and 1992-93 Community Development Block Grant programs and authorizes the following reallocation for the management of the 1817 Church Street property:


FROM:	1990-91 GRANT YEAR (SIXTEENTH YEAR):	
	1817 Church Street Leasehold/Safety Improvements	(\$7,315)
TO:	1992-93 GRANT YEAR (EIGHTEENTH YEAR):	
	1817 Church Street Building Management	\$7,315

AND, BE IT FURTHER RESOLVED that the Evanston City Council authorizes Evanston's City Manager to submit said program amendments in a form acceptable to the United States Department of Housing and Urban Development.

This Resolution shall be in full force and effect from and after the date of its passage and approval in the manner provided by law.
