A RESOLUTION


Canvassing the Results of the Consolidated Municipal Election

WHEREAS, the official Canvassing Board consisting of the Mayor, the City Clerk and the First Assistant Corporation Counsel for the City of Evanston, and the Town Supervisor, Town Assessor and Town Clerk for the Town of the City of Evanston, find from the returns of said Consolidated Election that the following votes were cast for the candidates indicated:




