**A RESOLUTION**


**Appointing a Director and Alternate Director  
to the Solid Waste Agency of Northern Cook County**

WHEREAS, the City of Evanston is a member of the Solid Waste Agency of Northern Cook County ("the Agency") and, pursuant to the Agency Agreement establishing the Agency, is entitled to appoint a Director and one or more Alternate Directors to the Board of Directors of the Agency,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That the City Council appoints Edmund B. Moran, Jr., Alderman, as the City's Director on the Board of Directors of the Agency and appoints Roger D. Crum, City Manager, as its alternate Director, in each case for a term expiring April 30, 2001, or until his successor is appointed.

SECTION 2: That this Resolution shall be in full force and effect from and after the date of its passage and approval in the manner required by law.

19. ENTRY BY LESSOR. Lessor may have access to space at reasonable times upon 24 hours notice to Lessee, except in cases of emergencies. In the event 24 hours is impracticable, Lessor may enter property any time reasonable under the circumstances. See Appendix C.
20. NOTICES. Notices to Lessor shall be in writing addressed to the attention of the NCC, NCAC, 927 Noyes Street, Evanston, Illinois 60201. Notice to Lessee shall be addressed to Lessee at his or her address as stated on page one of this document. Whenever a sublessee terminates this lease, the sublessee must do so by registered mail or by personal delivery, submitting one (1) notice to the NCC and one (1) notice to the Lessee. Said notices are also to be delivered not less than ninety (90) days prior to the first day of the month of the contemplated termination. See Lease provision 6. Upon termination all obligations under this lease shall be performed in full except if specified differently in this lease, including but not limited to provisions outlined in Lease Provision 15 "Security Deposit." See Appendix C.
