A RESOLUTION

Amending the 1991, 1994, 1995, 1998 and 1999
Community Development Block Grant Programs
and Authorizing the Reallocation of Unexpended
Funds from those Program Years

WHEREAS, The Evanston City Council with passage of Resolutions 6-R-91, 4-R-94
10-R-95, 4-R-98, and 4-R-99 did direct the City Manager to file applications for Community
Development Block Grant program activities with the United States Department of Housing and
Urban Development (HUD); and

WHEREAS, the aforesaid applications were approved by HUD; and

WHEREAS, unexpended funds are available after implementation of certain Community
Development Block Grant program activities; and

WHEREAS, reallocation of said funds requires amendment of the City of Evanston's
previous applications; and

WHEREAS, the City's Housing and Community Development Act Committee did hold
Public Meetings on November 15, 2000 and December 12, 2000 to hear public opinion on said
reallocations according to the Community Development Citizen Participation
Plan #; NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF EVANSTON, EVANSTON, COOK COUNTY, ILLINOIS:


SECTION 1: That the City's 1991, 1994, 1995, 1998, and 1999 applications for


