**A RESOLUTION**

**Abating Taxes Levied for the Year 2004  
Heretofore Levied To Pay Principal And Interest On  
Not to Exceed \$35,820,000 General Obligation Corporate Purpose Bonds,  
Series 1997, of the City of Evanston  
Cook County, Illinois**

**WHEREAS, The City Council of the City of Evanston, Cook County, Illinois, did on the 8<sup>th</sup> day of April, 1997, adopt Ordinance 41-0-97, an Ordinance entitled:**

**An Ordinance providing for the issuance of not to exceed \$35,820,000 General Obligation Corporate Purpose Bonds, Series 1997, of the City of Evanston, Cook County, Illinois, and in the accompanying Bond Order providing for the levy and collection of a direct annual tax for the payment of the principal of and interest on said bonds; and**

**WHEREAS, the City Council pursuant to Resolution 54-R-04 did abate the taxes for such General Obligation Corporate Purpose Bonds Series 1997 of the City of Evanston, Cook County, Illinois for the Year 2004 by the amount of \$1,621,155.00; and**

**WHEREAS, the City Council did in December 13, 2004 conduct a public hearing on the 2004 tax levy according to law; and**

**WHEREAS, it has now been determined that Resolution 54-R-04 should be repealed; and**

**WHEREAS, there is available from other sources the amount of \$1,025,458 which may lawfully be utilized to pay sums due on said bonds for which taxes were heretofore levied:**

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL, OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:**

**SECTION 1: That Resolution 54-R-04 be and it is hereby repealed.**

**SECTION 2: That the taxes heretofore levied and provided for in the Ordinance and in the accompanying Bond Order providing for the issuance of not to exceed \$35,820,000 General Obligation Corporate Purpose Bonds, Series 1997 of the City of Evanston, Cook County, Illinois, passed April 8, 1997, as Ordinance 41-0-97, be and the same hereby are abated for the year 2004 by the amount of \$1,025,458.**

**SECTION 3: That the City Manager, upon passage of this resolution, shall cause to be filed with the County Clerk of Cook County, Illinois a certified copy hereof and shall direct said County Clerk to abate the taxes heretofore levied under said Ordinance 41-0-97 and the accompanying Bond Order for the year 2004 in the amount of \$1,025,458.**

**SECTION 4: That this Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.**
