A RESOLUTION

**Abating Taxes Heretofore Levied to Pay Principal and Interest
on \$24,210,000 Corporate Purpose Bonds, Series 1994,
of the City of Evanston, Cook County, Illinois**

WHEREAS, the City Council of the City of Evanston, Cook County, Illinois, did on the 29th day of March, 1994, adopt Ordinance 22-0-94, an Ordinance entitled:

An Ordinance providing for the issuance of \$24,210,000 Corporate Purpose Bonds Series 1994, of the City of Evanston, Cook County, Illinois, and in the accompanying Bond Order providing for the levy and collection of a direct annual tax for the payment of the principal of and interest on said bonds; and since Ordinance 22-0-94 and the accompanying Bond Order remains in your office;

and

WHEREAS, said Ordinance provided for the levy of taxes sufficient to pay the Series 1994 Bonds, the remaining levies being as follows:

WHEREAS, the City issued its Series 1999 \$37,525,000 (the "Series 1999 Bonds") General Obligation Bonds, a part of the proceeds of which was used to refund the interest on and principal of the Refunded Bonds and pay such principal on the earliest Call Date for the Refunded Bonds. The refunding resulted in a reduction in debt service for the Refunded Bonds, and the Tax Levies may be abated as indicated,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

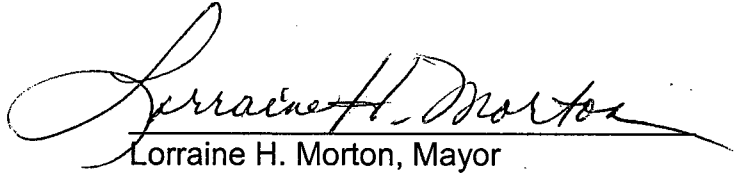
SECTION 1: That, accordingly, the Cook County Clerk is hereby notified and directed to make an abatement of the taxes heretofore levied for the payment of the Series 1994 Bonds for the years and in the amounts as follows:

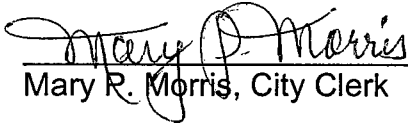
SECTION 2: That the City Manager, upon passage of this Resolution, shall cause to be filed with the County Clerk of Cook County, Illinois, a certified copy hereof and shall direct said County Clerk to abate all the

taxes heretofore levied under said Ordinance 22-0-94 and the accompanying Bond Order for all the levy years listed in this Resolution.

SECTION 3: That this Resolution shall be in full force and effect from and after the date of its passage and approval in the manner provided by law.
