**A RESOLUTION**

**Amending the 2008 Community Development Block Grant Program  
and Authorizing the Reallocation of Unexpended Funds**

**WHEREAS**, in a review of completed projects funded by Community Development Block Grant programs in prior years, sixty-seven thousand, five hundred thirty-one dollars (\$67,531.00) in unexpended funds has been identified from completed projects for reallocation to other eligible Community Development Block Grant (CDBG) activities in order to address needs in the year ahead, and to maintain timely use of funds per United States Department of Housing and Urban Development (HUD) guidelines; and

**WHEREAS**, the FY 2008 CDBG program activities, for which the Evanston City Council directed the City Manager to file an application with HUD, were approved by HUD, and reallocation of said funds requires amendment of the City's FY 2008 CDBG application; and

**WHEREAS**, the City of Evanston did publish the thirty (30) day comment period from December 7, 2009, through January 6, 2010, and the City's Housing and Community Development Act Committee did hold a public meeting on December 15, 2009, to hear public opinion on said proposed reallocations according to the CDBG Program's Citizen Participation Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF  
THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

**SECTION 1:** That the foregoing recitals are hereby found as fact and made a part hereof.


**SECTION 2:** That the City's FY 2008 application for Community Development Block Grant program activities are hereby amended, and sixty-seven thousand, five hundred thirty-one dollars (\$67,531.00) is approved for reallocation to the City's 2010/11 CDBG program as follows:
