This is a **once-in-a-generation opportunity** that will produce two documents:



Land Use

The way land is developed and used (residential, commercial, industrial, etc)



Zoning

Regulations that govern land use and building forms



Transportation


How our roads, sidewalks, trails, and bikeways connect and allow us to get around



Housing

How we ensure housing is attainable at all incomes and accessible to our most vulnerable populations

Climate

Building and operating with environmental preservation and climate resilience as a priority.



Equity & Racial Justice

Repairing historic harms around land development, community wealth building and access to resources.

Ensuring jobs and business opportunities for all Evanstonians




Public Health

This is our chance to **chart our path to 2045 together.**






OUR ROAD MAP






HOW IT ALL COMES TOGETHER

The People of Evanston

The people of Evanston are the drivers of this process.

The information you share will shape where the city invests, the contents of our future zoning ordinance, how new development occurs, and more!



Evanston City Council

The final plan and ordinance will be adopted by city council.

The City of Evanston

The city will coordinate directly with each group to develop the plan and ensure all voices are being heard.

Consultant Team

The consultant team will support city staff in developing the plan, connecting with the community, and producing public facing materials.

Boards, Commissions, & Committees (BCCs)

BCCs will have an opportunity to engage throughout the process and provide technical guidance.
