1. CALL TO ORDER/ROLL CALL

The meeting was called to order at 3:03pm.

2. APPROVAL OF MINUTES

The February 22 minutes were approved by Jim Johnson and Matt Dinerstein.

3. PUBLIC COMMENTS

- A visitor shared an experience of a member who attempted to visit Double Clutch and was unable to get in due to there not being a doorbell and staff/other visitors not seeing him.
- A visitor shared that the next CTA ADA Advisory Committee meeting is on April 8.

4. ITEMS FOR DISCUSSION

Updates about previous inquiries and grievances

- Bus stop accessibility/CTA accessibility - Commission involvement and CTA visitor in April
 - Commission involvement: Director Thompson explained the importance of Committee calls for action to be presented to the Commission in order to be sanctioned
 - CTA Manager of ADA to visit in April: The Committee was asked to share any questions/topics for the speaker to review ahead of time.
 - FTA communication/complaint contact info: Contact information was provided as a resource which included CTA, RTA, and FTA organization summaries and

communication/complaint phone numbers and websites.

- Sound and public health: AMC Theatre in Evanston will be investigated by staff from Health and Human Services Dept.

Review of new inquiries/grievances

- Re-painting bike path along lakefront: Public Works Dept. reviewing this request
- Tactile buttons for fitness equipment: Buttons have been placed on 3 machines in the Levy Fitness Room along with small signs to identify adaptations to the community. Orientation to the new system available from Levy staff.
- Ramp request for Noyes main entrance: many items at Noyes included in ADA Transition Plan. Accessible entrance signs and doorbell recently placed.
- Grace Lutheran Church curb cuts: Depts reviewing this request.
- CURB transportation inquiry: CURB provides accessible transportation for riders getting picked up in the City. Will drive to suburbs but will not pick up in suburbs.

Training/education updates

- ADA Advisory Committee Work Plan check in: Manager Ruiz discussed increasing focus on ADA Transition Plan in upcoming quarter
- ReelAbilities: Member Julia and Manager Ruiz to have a phone meeting with a representative to discuss upcoming film showing in Evanston. Committee was encouraged to share any questions for the representative.
- Parks & Rec Dept new inclusion acknowledgement for vendors: all vendors working with the Dept. must acknowledge the Inclusion & Accessibility Policies, are provided with Inclusion resource and Gender Diversity resource

- A member suggested additional future trainings related to service animals and accessibility on public transportation.
